

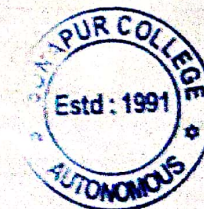
ST Scholarship Assam 2026 – Apply Online for Pre-Matric & Post-Matric Scholarship

Scholarship Categories

The ST Scholarship Assam 2026 is divided into two categories:



1. Post-Matric Scholarship

- Applicable for students studying in:
 - Class XI & XII
 - ITI
 - Diploma
 - Undergraduate Courses
 - Postgraduate Courses
 - Professional Courses

Eligibility Criteria

Post-Matric Scholarship (Class XI to PG)

Applicants must satisfy the following conditions:

- Must belong to a recognized **Scheduled Tribe (ST)** community.
- Must have passed the previous qualifying examination from a recognized board or university.
- Annual family income should not exceed **₹2.50 lakh**.
- Aadhaar-linked bank account is compulsory.
- Applicant should not be receiving another scholarship.
- Must be studying in a recognized educational institution.

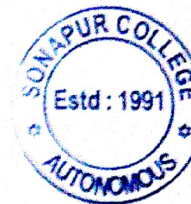

How to Apply for ST Scholarship Assam 2026?

Eligible students can apply online by following these simple steps:

1. Visit the National Scholarship Portal (NSP).
2. Click on **New Registration**.
3. Complete the registration process using Aadhaar and mobile number.
4. Login with your credentials.
5. Select **Pre-Matric** or **Post-Matric Scholarship**.
6. Fill in all required personal and educational details.
7. Upload the necessary documents.
8. Verify all information carefully.
9. Submit the application form.
10. Download and print the acknowledgement for future reference
