Required documents:

4. School Leaving Certificate/Original Pass Certificate.
5. HS Registration and Admit Card.
6. HS Marksheet and Pass Certificate.
7. Transfer Certificate from previous school/college.
8. Migration Certificate (if applicable).
9. Caste Certificate (if applicable).
10. Gap Certificate (if applicable).
11. Domicile Proof (exp. Aadhar/Voter/ Ration Card etc.).
12. Ration Card/ Income Certificate (for the students of **ARTS** Stream seeking fee waiver)

Note: No cash payment will be accepted. Payments will be accepted in online mode only.

Guidelines for Fee Waiver/ Free Admission:

1. An income certificate (of income less than Rs. 4 Lakhs per annum) from the local revenue circle officer.
Or,
Ration Card issued by the competent authority.
2. Free Admission is only for Domicile State of Assam only.
3. A declaration from the students that neither of the parents (father or mother) of the students is an employee of state/central government, department or its undertaking. If such a declaration is found to be false, the admission shall be cancelled and the admission fee shall be realized from such students.
